"I do agree, by signing this GLLS member application form, that I will abide by all the rules and regulations set forth by GLLS and INEX, including, but not limited to, the following:

1. I understand GLLS is promoting safe racing. Participants are expected to conduct themselves in a safe manner and to abide by any and all safety related procedures. Anyone who does not or whose actions jeopardize their safety or the safety of others will be dealt with immediately. Anyone associated with a team (driver, team personelle, affiliated person, etc.) that displays a lack of proper conduct may be asked to leave the track, and may receive a points/fine/incurred expense penalty. Courtesy, respect and professionalism is expected by all, under all circumstances.
2. I have, or will have, familiarized myself with all the GLLS rules and regulations, including car specifications and safety rules, and I specifically agree to abide by all the GLLS rules, including all rules and regulations printed in INEX's annual rule book, clarifications and any new prescribed rules posted on INEX's internet website and/or in All The Dirt! Racing News.
3. I agree that I shall be the sole spokesperson for myself, the car owner, and the crew in all matters pertaining to compliance with the rules and regulations and I agree and understand I am responsible for the conduct of my crew.
4. I agree and understand that by submitting my race car for various technical and safety inspections, **I certify that the race car meets all the rules and regulations for participation in GLLS sanctioned events, and I understand that the burden of proof will rest upon me to show that I am in compliance with all of the GLLS rules and regulations,** and I understand violation of various rules can result in a fine, suspension and loss of all national, all regional and all track points.
5. I agree to appropriately use all required stickers, decals and patches and I understand that failure to do so will result in loss of points and forfeiture of all money and awards for the event.
6. I agree that all decisions of GLLS race officials, or track officials, regarding the interpretation and application of the GLLS rules, and the scoring of positions, shall be non-litigable. I further covenant and agree that I will not initiate any type of legal action against GLLS, or a GLLS promoter, to challenge such decisions, to seek monetary damages, to seek injunctive relief or to seek any other kind of legal remedy. I understand that if I pursue any such legal action, which violates this provision, then I expressly agree to reimburse GLLS, or the GLLS promoter, for all of its attorney's fees and costs in defending against such legal action. In addition, I understand and accept that if I violate this provision, and initiate any type of legal action against GLLS, or a GLLS promoter as described above, that my GLLS competitors license will be immediately suspended and I will not be allowed to race again in the current year. Also, I will not be issued a new GLLS membership for a minimum of three (3) years from the date of the filing of such legal action. I also understand that the GLLS rule book expressly defines which decisions of race officials or GLLS officials can be appealed, and outlines the process by which the driver may appeal decisions by officials.
7. I agree to release all advertising and promotional rights to my name, car and likeness to GLLS, its sponsors and affiliated media including, but not limited to INEX.
8. I understand that all points, awards and money earned will be paid to the driver. If payments are to be made to someone other than the driver, it is the drivers' responsibility to provide all tax info to GLLS.
9. I understand that a portion of my annual membership fee will be used for a participant accident insurance policy.
10. I understand that from time to time, GLLS and its sponsors and partners may send emails to me that contain information on GLLS or products and services available to me as a racer.
11. I understand GLLS is a sanctioned INEX racing series and all INEX rules must be abided by.
